**FIREARMS ACT 1968 (AS AMENDED):  
AUTHORITY OF THE SECRETARY OF STATE UNDER SECTION 5**

I am directed by the Secretary of State to say that, under section 5 of the Firearms Act 1968 (as amended), she hereby authorises you to have in your possession, and transfer, in the course of your business as freight forwarding agents, prohibited weapons and prohibited ammunition subject to section 5 of the Firearms Act 1968 (as amended) refers.

Prohibited weapons and prohibited ammunition for which an authority of the Secretary of State is required must **not** be transferred to any person who does not hold an authority of the Secretary of State under section 5 unless that person is exempt from the need to hold an authority by virtue of the Act.

This authority is valid until **30 June 2018** and is given on the following conditions:-

1. that the prohibited weapons and prohibited ammunition are never owned by and/or held at the premises of Grange Shipping Limited at any time;
2. that the prohibited weapons and prohibited ammunition are transported using only those carriers who hold an authority under section 5 of the Firearms Act 1968 (as amended);


3. that the chief officer of Norfolk/Suffolk Constabularies and the Home Office, Drugs & Firearms Licensing Unit, Firearms Section are notified **in advance** of any change of company name, company address, named authority holder or change of procedure for the safekeeping of prohibited consignments. *Failure to comply with this procedure will invalidate this authority;*
4. that **Mr John Charles Grange** ensures that all reasonable precautions are taken to secure the safe custody of the prohibited weapons and prohibited ammunition and that proper records of all transfers involving the prohibited weapons and prohibited ammunition are kept; and
5. that this authority shall no longer be valid if **Mr John Charles Grange** ceases to hold office with Grange Shipping Limited.

This authority does not exempt you from the need to comply with the requirements of the Firearms Act 1968 (as amended).

Under section 5(5) of the Firearms Act 1968, it is an offence for a person to whom an authority is given under this section to fail to comply with any condition of the authority.

Under section 5(6) of the Firearms Act 1968, the Secretary of State is empowered to revoke this authority at any time.
